SPECIAL MEETING MINUTES Wednesday, March 21, 2012 12:00 p.m.

1. ESTABLISH QUORUM AND CALL TO ORDER

President Enns called the meeting to order at 12:12 p.m.

Board members present: President Robert Enns, Vice-President Hal Fones, Directors Shirley Lyon and Michael Foster. Director Dan Chivens was absent.

2. PUBLIC COMMENTS

President Enns opened the meeting to Public Comments.

Dave Zevely read a statement he prepared highlighting the improvements that have been made over the years to the District's Safety Policy, IIPP and ongoing CWEA certifications. He stated that the safety accomplishments have been recognized by the State and the CWEA certifications are a way to recognize knowledge and professionalism. Zevely concluded that the District has a good solid crew now and he hopes to see it continue.

Manager Callahan asked for clarification on the 3/26/12 Special Meeting Agenda and whether or not this was to include discussion on Frank Cunningham or the status of collection and monitoring sytem as requested by Director Foster in the 3/15/12 Regular Meeting. President Enns asked that the remainder of the Board compile their questions for Cunningham and this could be agendized for the next Regular Board Meeting along with the collection and monitoring system discussion.
