SPECIAL MEETING MINUTES AUGUST 18, 2010

1. ESTABLISH QUORUM AND CALL TO ORDER

President Enns called the meeting to order at 4:30 p.m. Board members present were President Enns, Vice-President McHale and Directors Fones, Lyon and Foster. Staff present was District Manager Callahan. Consultant present was Dale McGee, Catalyst Consulting.

2. PUBLIC COMMENTS There were no public comments.

3. PUBLIC EMPLOYEE PERFORMANCE EVALUATION pursuant to Government Code Section 54957 Title: District Manager

OPEN SESSION: 6:00 PM

4. ANNOUNCE ACTION TAKEN IN CLOSED SESSION There was no action taken to announce.

5. ESTABLISH QUORUM AND CALL TO ORDER

The meeting reconvened at 6:10 p.m.

Board members present were President Enns, Vice-President McHale and Directors Fones, Lyon and Foster. Staff present was District Manager Callahan, Administrative Services Officer Brookins and Administrative Services Technician Martin.

There were no visitors present.

6. PUBLIC COMMENTS There were no Public Comments.

7. STATUS REPORT ON THE DISTRICT OPERATIONS AND MAINTENANCE GARAGE PROJECT Manager Callahan provided a project timeline. He reported that the building permit should be issued by August 23, at the latest, with advertising of the RFP to follow. The timeline shows an estimated nine months for completion of the construction phase. Enns suggested including a time constraint in the project contract as part of the selection process. Callahan indicated there is a completion time set forth in the contract documents. 8. STATUS REPORT ON MORRO BAY/CAYUCOS WASTEWATER TREATMENT PLANT PROJECT Manager Callahan's written report was received. He reported on the tours he and Morro Bay staff took of two PERC-designed wastewater facilities, the Santa Paula WWTP (August 3) and the Mountain House CSD WWTP (August 13). He expressed some operational concerns but reported that both facilities produce a high quality effluent. He noted that odors were detected and that at this time there are no water reclamation plans in effect. Callahan added that the PERC Customized Design Report (CDR) should be received September 8, 2010, after which an independent review and evaluation of both a PERC-designed facility and the MWH-designed facility will take place.

Director Foster asked to see the most recent budget for the Morro Bay/Cayucos WWTP Upgrade to date, with specificity. ASO Brookins indicated the budget should be included at the September 9 JPA meeting.

The Board discussed the WWTP Upgrade Project Manager, Dennis Delzeit, P.E. President Enns asked staff to include the minutes from TAC meetings at District Board meetings, as well as any reports by Delzeit.

A. District Manager's Report (Callahan) - July 2010

Manager Callahan's written report was received. Board members provided input for the Sanitary District Newsletter, with Foster suggesting including an announcement asking for bids for the O&M Garage Project.

ASO Brookins written report was received. He reported the annual audit went smoothly and commended staff on their preparation for and assistance during the audit.
