SPECIAL MEETING MINUTES THURSDAY, FEBRUARY 16, 2012 5:30 P.M.

1. ESTABLISH QUORUM AND CALL TO ORDER President Enns called the meeting to order at 5:30 p.m.

Cayucos Sanitary District Board members present were President Robert Enns, Vice-President Hal Fones, and Directors Shirley Lyon, Michael Foster and Dan Chivens.

President Enns announced Closed Session.

3. RECONVENE TO OPEN SESSION AND ANNOUNCE ACTIONS TAKEN IN CLOSED SESSION

The meeting reconvened to Open Session at 6:10 p.m. President Enns announced that no actions were taken in Closed Session.

Staff present was District Manager Bill Callahan, Administrative Services Officer (ASO) Lewis Brookins and Administrative Services Tech Nancy Martin.

Visitors present were Dorothy Fones, Dr. James Brescia, Cayucos Elementary School Superintendent, Science Teacher Lisa Shinn, the sixth grade class and Wendy Laumer, grant writer, and other parents and students.

3. PRESENTATION FROM CAYUCOS ELEMENTARY SCHOOL "WASTEBUSTERS" PROGRAM WITH CONSIDERATION TO PROVIDE ANNUAL FUNDING TO THE WASTEBUSTER PROGRAM

Cayucos Elementary School Science teacher Lisa Shinn and sixth grade students gave a presentation with a slide show and information regarding their program to reduce litter in town, on the beach and in the creeks. In addition to regular trash clean ups, students spearheaded the elimination of plastic

utensils and Styrofoam dishes in the cafeteria and are working toward making Cayucos litter free by keeping the public aware of environmental effects of trash in our creeks and on the beach, increasing the number of trash and recycling receptacles available on the streets, and organizing monthly neighborhood clean ups.

Manager Callahan asked board members to consider funding the Wastebusters Program for the remainder of Fiscal Year 2011/2012 in the amount of \$500.00.

MOTION: First by Foster with second by Chivens to contribute \$500.00 to the Wastebusters Program for the remainder of Fiscal Year 2011/2012.

Director Lyon recommended increasing the amount to not to exceed \$1,000.00.

AMENDED MOTION: Director Foster amended the motion. Contribute \$1,000.00 to the Wastebusters Program for the remainder of the Fiscal year 2011/2012. Chivens seconded the motion. VOTE: 5-0

Callahan stated he would explore options with Mission Country Disposal for purchasing additional litter and recycling receptacles.

- ASO Brookins' written report was received. At the January Board meeting staff was asked to review the current committee structure, and consider combining the Investment Committee with the Budget/Finance Committee and include overseeing risk management. Brookins reported that the District Investment Policy states that the Board appoints an individual Board Member as Financial Liaison, and recommended the term "Board Member Financial Liaison" be used instead of Investment Committee. Additionally, Brookins recommended the Budget and Finance Committee retain the same name but include the function of risk management. Enns asked Board members for any changes requested in committee assignments; there were none.
