> REGULAR MEETING MINUTES Thursday, June 18, 2015 6:00 p.m.

1. ESTABLISH QUORUM AND CALL TO ORDER

President Enns called the meeting to order at 6:00p.m.

Board members present: President Robert Enns, Vice-President Dan Chivens, Director Shirley Lyon, Director Dan Lloyd, and Director Cary Maffioli.

Staff present: Manager Rick Koon, and Administrative Services Billing Manager Danielle Crawford.

Guests present: Bruce Keogh, City of Morro Bay (WWTP)

2. PUBLIC COMMENTS

President Enns opened the meeting to Public Comments.

Bill Martony – Morro Bay resident. Said he is here to find out the site selection of the proposed new plant. He would also like to know what type of plant Cayucos plans to build and asked if the Sanitary District has customers for the recycled water.

Hearing no further comments, President Enns closed Public Comment.

3. PRESENTATION AND REVIEW OF CITY OF MORRO BAY 2015/2016 WWTP BUDGET

Koon went over Morro Bay's proposed FY 15/16 WWTP budget. Staff has reviewed the CSD's portion of Morro Bay's.

Maffioli asked about the revenue going up to 44%.

Keogh stated that a large portion of that has to do with the recent rate increase.

Koon asked Keogh about the rate increase.

Keogh elaborated by saying it will go into effect on July 1, 2015, first payments received by August 10, 2015.

Enns asked the outcome of the 218 vote.

Keogh said of the ballots sent, 5,500 yes and 900 protests, the 218 passed.

Koon asked if Morro Bay Council approved their budget.

Keogh said yes, approved at their June 9, 2015 meeting.

President Enns opened the meeting to Public Comments.

Hearing none, Enns closed Public Comment and moved on to agenda item number 4.

4. CONSIDERATION TO APPROVE THE MAJOR MAINTENANCE AND REPAIR PLAN (MMRP) PORTION OF FY 2015/16 CITY OF MORRO BAY WASTEWATER TREATMENT PLANT (WWTP) BUDGET

Keogh summarized his budget notes, more specifically the MMRP portion.

Lloyd asked if in another year they will have a better idea of the continuing costs of the MMRP.

Keogh said yes, by the end of this year, they will know more and have a clearer picture. He said that the Headworks have helped tremendously and then he briefly summarized the proposed projects for the next fiscal year.

Chivens suggested using redi-rock material, and then it can be used for retaining walls.

President Enns opened the meeting to Public Comments.

Hearing no further comments, President Enns closed Public Comment.

MOTION: 1st by Chivens, 2nd by Maffioli to approve the CSD's portion of the MMRP costs proposed at \$116,250.00.

ROLLCALL VOTE: Enns-yes, Chivens-yes, Lyon-yes, Lloyd-yes, Maffioli-yes. VOTE 5-0 Motion passed

With Board permission, President Enns skipped to agenda item number 7.

7. UPDATE ON THE CAYUCOS WASTE WATER PROJECT

Koon went over all recent happenings in site selection including Cayucos Creek, Old Creek Road, and Toro Creek and said they are currently working on the chartering process. He said they do not have a site selected yet. These questions will be answered within the next six months as outlined in the WSC scope. Koon then gave an overview of the approved WSC studies.

Enns said they spoke at the Lioness's, and received favorable feedback from the community.

Lyon commented on the basic questions from the public and said Enns did a great job explaining where we are at. She feels the Board has the community support.

Enns said they also had the chance to speak at the Board of Realtor's meeting. He mentioned that Keogh and Livick were there and had a Power Point presentation as well. Enns complimented Keogh's presentation and praised the realtor group saying that they asked some very good questions.

President Enns opened the meeting to Public Comments.

Bill Martony – Morro Bay resident. Commented on the site location being Cayucos Creek maybe on his property line, or if the Davis Ranch, he would be downwind of the plant.

Hearing no further comments, Enns closed Public Comment and the Board resumed with the regular agenda order moving on to item number 5.

5. CONSIDERATION TO APPROVE TWO YEAR AUDIT SERVICES AGREEMENT WITH MOSS, LEVY AND HARTZEIM

Koon went over the renewal of the Auditor's contract.

President Enns opened the meeting to Public Comments. Hearing no further comments, President Enns closed Public Comment.
